



## LIMITED LIFETIME CARPET TILE WARRANTY

**InstaCarpet warrants its nylon carpet tiles for commercial & residential application when professionally installed indoors, under CRI guidelines and properly maintained. This warranty belongs to the original end user and is not transferable.**

By starting installation of this product, you are agreeing that you have read and understand all installer/owner's requirements and responsibilities and are aware that deviating from the instructions and recommendations in this installation guide may result in voiding the product warranty. ### **All Nylon InstaCarpet are warranted against:**

#### **WEAR**

Carpet tiles will retain 90% of their surface pile weight from abrasive wear. "Abrasive wear" means fiber loss from the carpet tiles through normal abrasion, not crushing or flattening of the carpet pile in any area, nor staining, soiling, fading, or change in carpet tile appearance, nor fiber loss due to abnormal usage of the carpet tiles.

#### **COLORFASTNESS**

InstaCarpet warrants that nylon carpet tile will not show a significant color change during this time as tested by AATCC Test Method 16 Option E with rating of 5 on gray scale for color change due to normal exposure to sunlight and atmospheric contaminants. The warranty excludes color change due to direct or advanced exposure to sunlight.

#### **EDGE RAVEL/ZIPPERING**

Carpet tiles will not edge ravel or zipper; this warranty will not include edge ravel where carpet tiles are cut for access to floor outlets, around trench header ducts, or improper cuts that could cause unraveling or frayed ends.

#### **DELAMINATION**

InstaCarpet warrants that the carpet tiles will not delaminate from secondary backing during the warranty period. Chair pads and mats are always recommended.

#### **DIMENSIONAL STABILITY**

InstaCarpet guarantee that the dimensions of the backing of all SDN PA tiles will remain stable within the limit fixed by ISO 2551 (EN 986) and will not vary more than +/-0,20%. This guarantees that there will not be any elongation of the backing under the static loading of conventional office furniture. The initial values of the dimensions will be kept.

#### **ANTI-STATIC**

InstaCarpet warrants that nylon carpet tiles, if correctly installed and regularly maintained as per our published recommendations, will not generate static greater than 3.5KV for Lifetime as tested by AATCC Test Method 134.



### **CASTOR CHAIR COMPATIBILITY**

Chair mats are always recommended to ensure that the carpet tiles will perform under the stress of moving and loaded office chairs as tested by DIN standard 54328 after 25000 revolutions.

### **PERFORMANCE FAILURE**

As long as the carpet tiles has been installed in accordance with InstaCarpet installation manual (installation practice current at the time of installation), we will offer to repair, offer an allowance, or offer a credit to cover the cost of repair or material only to the affected area. The credit will apply to new carpet tiles of the same or equivalent quality and will be passed to your retailer.

InstaCarpet will not be liable for any incidental, indirect, special, or consequential damage in any case e.g., expense of removal of furniture, partitions, temporary walls, extra handling, and labor involved in bordering or sculpturing.

### **WARRANTY COVERAGE PERIOD**

This warranty coverage runs for lifetime from the date of your carpet tiles installation.

### **WARRANTY PRORATION**

Proration means the warranty protection reduces over time

## **OWNERS OBLIGATION**

- Keep the original invoice or receipt which shows the proof of purchase of the carpet tiles from the retailer with the installation charges.
- The carpet tiles must be installed indoors, for commercial or residential use.
- Have the carpet tiles installed in accordance with installation manual.
- Maintain and clean your carpet tiles by following the cleaning and maintenance guide of InstaCarpet.
- Install carpet tiles with the recommended adhesive, speak to your retailer for recommendation.
- Any questions related to the product and its warranties should be directed to retailer.

## **WARRANTY EXCLUSIONS**

### ***This warranty does not include:***

- This warranty does not cover burns, cuts, pulls, tears, or any other damage caused by improper cleaning agents or installation methods.
- Carpet tiles damaged by any abnormal activity, sharp objects, or damaged chair casters.
- Non-food and non-beverage stains caused by substances, including but not limited to, cosmetics, bleaches, inks, vomit, blood, feces, etc.
- Carpet tiles placed in areas where extreme points load are sustained for prolonged periods of time.
- The warranty does not cover defects that may arise from flooding or the presence of excessive moisture, excessive alkalinity.
- This warranty shall be void if products are not handled, installed, and maintained as per InstaCarpet installation guide (installation practice current at the time of installation).
- Warranty does not cover any problems or damages related to use of non-recommended adhesive. Please speak to your retailer for recommended adhesive.
- Color changes due to fading.
- Carpet tiles installed outdoors in direct sun exposure.
- Minor color variation in dye lots which may or may not be visibly apparent between the sample and the carpet tiles installed.
- If your new or replacement carpet tiles has been discontinued by InstaCarpet.
- Carpet tiles installed on stairs or in bathrooms are not covered under this warranty.
- Spread the carpet tiles prior to installation for any visible manufacturing defects. InstaCarpet or your retailer will not cover the labor cost, or any other cost involved if installed with visible defects.



### HOW TO CLAIM

Warranty claims must be addressed with your retailer within sixty (60) days from the time the claimed defect is discovered along with a photograph and/or sample that clearly shows the warranty problem. **Note:** Any manufacturing defects should be notified within the 15 days of installation.

You (the original purchaser) should notify the authorized retailer and submit in writing, the following:

- A valid proof of purchase in the form of sales receipt or other documents, which establish proof of purchase.
- A detailed description of the problem and/or a photograph/sample that clearly shows the warranty problem.

### LIMITATIONS

This warranty is applicable to the original purchaser and at the original installation site. This warranty is not transferable.
